Thornton Township Clerk called the Thornton Township Board of Trustees Meeting to order at 05:43 p.m. Clerk Wells called the roll call.

NEW BUSINESS:

Supervisor Henyard entertained a motion to have a consent agenda. The motion was made by Trustee Jones, seconded by Trustee Washington. There being no questions or comments, Clerk Wells called the roll.

On the Roll Call, the vote was:

YES: 4 Trustees Washington, Jones, Gray-Everett, and Supervisor Henyard ABSENT: 1 Trustee Gonzalez

There being four affirmative votes, the motion carried.

Supervisor Henyard entertained a motion to approve A, B & C on a consent agenda. A) Should a portion of Wausau Avenue next to the Township Building be renamed to the Honorable Frank Zuccarelli Drive?

B) Shall October 29, Frank Zuccarelli's birthday, be declared a Thornton Township holiday?

C)Should the Thornton Township logo be changed to include more purple, in honor of Frank Zuccarelli's work with the Gift of Hope?

The motion was made by Trustee Gray-Everette, seconded by Trustee Washington. Trustee Jones stated "even though these resolutions are in Honor of Frank Zuccarelli and have a lot of merit, as a Trustee/Elected Official of Thornton Township, I'm in opposition of it, because I'm not a politician... I'm an Elected Official". "I don't want to Honor a person who spent almost 30 years, at Thornton Township by doing shenanigans or tricks for the ballots regarding his name". Supervisor Henyard opened the floor to any other questions. Supervisor Henyard stated that "no one is doing any politics, trickery, or anything as it relates to Frank Zuccarelli, that man was great to all 17 municipalities".
