**June 20, 2023**

Her office was relocated within the building so that her original office can be used for other business. Assessor Elston did not call to ask for any information about what was going on. He says that there were no files left out, everything was locked up. He says that it has been brought to his attention that there has been a office set up in the Calumet city building for the Assessor and he informed the Supervisor and the Attorneys and that is why this motion is placed on today's Agenda and it is up to the Board to decide rather or not the Assessor or any other body of the Government can operate outside of its normal Facilities.
