

TAX LEVY ORDINANCE

THORNTON TOWNSHIP ROAD DISTRICT

ORDINANCE No. 22-008

An ordinance levying taxes for all road purposes for Thornton Township Road District, Cook County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Thornton Township, Cook County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Thornton Township Road District on December 20, 2022 does hereby determine and declare that the sum of SEVEN HUNDRED EIGHTY THOUSAND EIGHT HUNDRED FIFTY SEVEN DOLLARS AND ZERO CENTS (\$780,857.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

- GENERAL ROAD FUND
- ROAD INSURANCE FUND
- ROAD ILLINOIS MUNICIPAL RETIREMENT FUND
- ROAD SOCIAL SECURITY FUND
- ROAD EQUIPMENT AND BUILDING FUND
- ROAD PERMANENT ROAD FUND

for the year 2022.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That the Board of Trustees hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Thornton Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
