**A RESOLUTION AUTHORIZING THE SUBMISSION OF AN ADVISORY  
PUBLIC POLICY QUESTION AT THE  
MARCH 17, 2026 PRIMARY ELECTION REGARDING EXPANDING THE  
SCOPE AND SERVICES OF THE THORNTON ASSISTANCE PROGRAM  
(TAP) TO INCLUDE SNOW REMOVAL SERVICES**

**WHEREAS**, Thornton Township, County of Cook, State of Illinois (the "Township") is a duly organized and existing township and a unit of a local government organized under the laws of the State of Illinois and is operating under the provisions of the Illinois Township Code, 60 ILCS 1/1-1 *et seq.*, and all laws amendatory thereto; and

**WHEREAS**, Section 80-80 of the Township Code (60 ILCS 1/80-80 *et seq.*) authorizes the Township Board to submit an advisory question of public policy for consideration to the registered voters of Thornton Township at the next regularly scheduled election; and

**WHEREAS**, the Township Board has a Thornton Assistance Program which supports eligible seniors with weekly lawn care services throughout the summer months; and

**WHEREAS**, the Township Board wishes to expand the services of the Thornton Assistance Program to include snow plowing and snow removal for the homes of eligible seniors; and

**WHEREAS**, the Township Board finds it in the best interest of the Township to seek to gauge public sentiment regarding whether residents desire the expansion of services of the Thornton Assistance Program.

**NOW, THEREFORE, BE IT RESOLVED**, by the Supervisor and the Board of Trustees of Thornton Township, Cook County, Illinois, as follows:

**Section 1:** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2:** The following referendum question shall be placed on the March 17, 2026 General Primary Election ballot to the electors of Thornton Township:

"Shall Thornton Township expand the scope and services of the Thornton Assistance Program (TAP) to include snow plowing and snow removal services for seniors within the Township?"	YES <input type="checkbox"/>

**Section 3:** The Township Clerk is hereby authorized and directed to file a certified copy of this Resolution with the Cook County Clerk within the time authorized by law to certify a proposition to be submitted to the electors of the Township at the March 17, 2026 General Primary Election.

**Section 4:** If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution.

**Section 5:** All resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.


**Section 6:** This Resolution shall be in full force and effect immediately upon its passage, approval, and publication as provided by law.
