As identified in the Thornton Township CDBG 2022 Program Year

Section 2. That the Supervisor and Township Clerk is hereby authorized to sign the application and various forms contained therein, make all required submissions and do all things necessary to complete the application for the funds requested in Section 1 of this Resolution, a copy of which application is on file with the Township.

Section 3. That the Supervisor and Township Clerk is hereby authorized to certify that matching funds which have been identified as supporting its projects as set out within its application will be made available upon the approval of the projects by the County of Cook, Illinois or the prorated share thereof.

Section 4. This resolution shall be in full force and effect from and after its passage, approval and publication as provided by law. If any portion of this Resolution is invalid, that portion shall be stricken from this Resolution and the remainder of this Resolution is invalid, that portion shall be stricken from this Resolution and the remainder of this Resolution shall continue in full force and effect to the extent possible.




