RESOLUTION

TRANSFER OF APPROPRIATION FOR  
THE GENERAL FUND

WHEREAS there was adopted on the 24th day of May, 2022 by the Board of Trustees of Thornton Township, Cook County, Illinois, a Budget & Appropriation Ordinance for the fiscal year beginning March 1, 2022 and ending February 28, 2023, and

WHEREAS it now appears that certain adjustments between appropriated line items in the General Fund in said ordinance are desirable and necessary, and

WHEREAS Section 3 of the Illinois Municipal Budget Law (50 ILCS 330/3), as approved July 12, 1937, as amended, authorizes transfers between the various line items within any fund in such Appropriation Ordinance not exceeding 10% of the total amount appropriated in such fund by such ordinance, now therefore
