RESOLUTION
PROPERTY TAX LIMITATION LAW (PTELL) FOR
THE ROAD AND BRIDGE FUND

WHEREAS, 1-10 of the Property Tax Extension Limitation Law ("PTELL") provides that the Cook County Clerk shall extend a tax rate for the sum of the Township's funds that is not greater than the limiting rate; and

WHEREAS, PTELL 1-10 further provides that if the County Clerk is required to reduce the aggregate extension of a taxing district, the clerk shall proportionally reduce the extension for each fund unless otherwise requested by the taxing district; and

WHEREAS, the Board of Trustees of Thornton Township, County of Cook, State of Illinois (hereinafter "the Board") has adopted a levy for the year 2025 for taxes for the following purposes or funds of said township's Road and Bridge Fund, Road and Bridge IMRF Fund, Road and Bridge Social Security Fund, Road and Bridge Liability Insurance Fund, and Road and Bridge Equipment and Building and Road and Bridge Permanent Road and

WHEREAS, the Board has determined that if the County Clerk must extend taxes in an amount less than the aggregate amount of the levy for 2025 such reduction shall not be proportionate in all funds; but rather, shall be made as hereinafter specified;

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Thornton Township, County of Cook, State of Illinois, as follows:

Section 1. If the County Clerk is prohibited by PTELL from extending taxes for the full amount of the 2025 aggregate levy of Thornton Township, then in that event the levy for each of township's funds shall not be reduced proportionally.

Section 2. If the County Clerk of Cook County is prohibited by PTELL from extending taxes for the full amount of the 2025 aggregate levy of Thornton Township any necessary reduction of taxes shall be made in the following fund as specified:

Road and Bridge Fund - Corporate Fund

Road and Bridge Fund - IMRF Fund

Section 3. This Resolution shall be in full force and effect from and after its passage and approval as provided by law.
